Lord Berkeley to move that this House regrets that the Channel Tunnel (Arrangements with the Kingdom of the Netherlands) Order 2020 does not provide that frontier controls on rail passenger services may take place on moving trains for the benefit and convenience of passengers. *26th Report from the Secondary Legislation Scrutiny Committee*

Lord Falconer of Thoroton to move that this House regrets that the Prosecution of Offences (Custody Time Limits) (Coronavirus) (Amendment) Regulations 2020 do not provide sufficient measures to address the backlog of Crown Court trials; and that this House agrees with the conclusion of the 27th Report of the Secondary Legislation Scrutiny Committee which states that the extension of remand periods "delays justice for both the defendant and the victim and may add to the difficulties that prisons are facing during the pandemic. Extending remand can have extremely detrimental effects on the mental health of the individual and on the welfare of their families". *Special attention drawn to the instrument by the Secondary Legislation Scrutiny Committee, 27th Report*

Lord Foster of Bath to move that this House takes note of the Audiovisual Media Services Regulations 2020 (SI 2020/1062). *Special attention drawn to the instrument by the Secondary Legislation Scrutiny Committee, 30th Report*

Lord Green of Deddington to move that this House regrets that the Statement of changes in Immigration Rules, published on 22 October 2020, does not provide a clear and comprehensible description of the changes proposed, nor of their likely effect. *Special attention drawn to the instrument by the Secondary Legislation Scrutiny Committee, 33rd Report*

Baroness Thornton to move that, while welcoming the Health Protection (Coronavirus, International Travel) (England) (Amendment) (No. 7) Regulations 2021, this House regrets that they were not laid until 15 February despite the warning from the Scientific Advisory Group for Emergencies on 21 January that “reactive, geographically targeted” travel bans “cannot be relied upon to stop importation of new variants” of COVID-19; further regrets that Her Majesty’s Government failed to prevent the Brazilian strain of COVID-19 entering the United Kingdom; further regrets that the policy only applies to 33 “red list” countries and that 99 per cent of passengers arriving in the United Kingdom are therefore exempt; and calls upon Her Majesty’s Government to implement a comprehensive hotel quarantine on all United Kingdom arrivals to prevent the importation of new variants of COVID-19. *46th Report from the Secondary Legislation Scrutiny Committee*

Baroness Hodgson of Abinger to move that this House regrets that the Traffic Signs (Coronavirus) (Amendment) (England) Regulations 2021 (SI 2021/75) enable the continuation of e-scooter trials during the COVID-19 pandemic; further regrets the risk that any such trials which are undertaken while restrictions are in place to address that pandemic may not be reliable indicators of the safety of e-scooters; and calls on Her Majesty’s Government to publish their plans to address the illegal use of such scooters before any further such trials take place. *45th Report from the Secondary Legislation Scrutiny Committee*
